

Black Friday Gift Voucher Terms and Conditions

1. Arena Leisure Racing Limited (“ARC”) hereby provides the customer with the chance to purchase a gift voucher as detailed below (each a “Gift Voucher”):
 - a. £375 gift voucher - £125 on top free – for limited availability;
 - b. £210 gift voucher - £65 on top for free;
 - c. £155 gift voucher - £45 on top for free;
 - d. £120 gift voucher - £30 on top for free;
 - e. £80 gift voucher - £20 on top for free;
 - f. £28 gift voucher - £7 on top for free.
2. To be eligible for purchasing a Gift Voucher, customers must be aged 18 or over.
3. Each customer may purchase as many Gift Vouchers as they want. Upon a successful purchase of a Gift Voucher, the customer shall receive a code in their email address, as supplied when purchasing.
4. ARC reserves the right to limit the number of redeemable Gift Vouchers per hospitality booking over £5,000 to a maximum of four. ARC shall disclose to the customer the existence of such limit in any event prior to the customer completing the hospitality booking.
5. Each Gift Voucher may be redeemable in purchasing general admission tickets, restaurant and hospitality bookings at the following racecourses: Bath, Brighton, Chepstow, Doncaster, Ffos Las, Fontwell Park, Great Yarmouth, Hereford, Lingfield Park, Newcastle, Royal Windsor, Sedgefield, Southwell, Uttoxeter, Wolverhampton & Worcester Racecourses (each a “Racecourse”).
6. Hospitality and restaurant bookings shall be redeemed by calling the relevant Racecourse and sales team directly. Except for hospitality and restaurants, Gift Vouchers may not be redeemed by telephone and shall only be redeemed by providing the code received during checkout at the Racecourse’s website. No gift vouchers can be redeemed in-person at the Racecourse.
7. Gift Vouchers cannot be used for annual memberships, gift vouchers, sponsorships, nonracing and third-party events.
8. The Gift Voucher may be purchased from 27 November 2024 until 23:59 of 2 December 2024 and may only be used to purchase 2025 fixtures at the Racecourses.
9. Gift Vouchers are non-refundable, non-transferable and have no cash alternative.
10. Any unused/partially used Gift Voucher will expire on 31 December 2025 (the “Expiry Date”).
11. Any remaining Gift Voucher balance will remain in the customer’s balance until the Expiry Date. Whole or partially redeemed Gift Vouchers cannot be refunded.
